GRANT SUMMARY

B'nai Brith Canada is pleased to announce our **2020 Human Rights Initiative Grant Fund**. The goal of this grant fund is to inspire and finance human rights projects that are already established or are in later stages of the development process. These projects must promote themes beneficial to our Manitoba communities. Applicants are encouraged to be creative and innovative in furthering the development of their project and how it is delivered to others. Our expectation is that applicants will create a proposal and a budget outlining the nature of their project and its corresponding costs.

This grant follows the philosophy of the **Human Rights Code of Manitoba**, which is based on the universal declaration of human rights: **"The individual worth and dignity of every member of the human family."**

All residents of Manitoba may apply for this grant, regardless of age and religious affiliation. Applicants may apply as an individual or on behalf of a group or organization of which they are a member. Funds may be awarded to multiple recipients. Applications from previous recipients of this grant are welcome.

We believe that through the promotion of this grant fund, we can encourage the creativity and thought processes of individuals and groups who are interested in enhancing the educational and social experiences that their human rights project provides for others.

ABOUT US





B'nai Brith is Canadian Jewry's most senior human rights advocacy organization and has played a vital role in our country since 1875. The mission of B'nai Brith Canada is to encourage the highest interest of humanity, and to develop and elevate the mental and moral character of people of our faith. Our activities aim to promote the purest principles of philanthropy: honour and patriotism, to support science and art, and to help alleviate the suffering of those in need within our communities.

This grant fund falls under the advocacy arm of B'nai Brith Canada, the League for Human Rights. The League advocates for human rights and community service through advocacy, education, and community development. It builds inter-community relationships, conducts educational programs and engages in community action and legal/legislative interventions. The League also advocates for global human rights by working closely with international organizations and agencies, hosting conferences, lectures and educational forums, and engaging government and policy makers at all levels in the combat of human rights abuses. It is a vital and thriving constant voice for humanity all over the world.

ELIGIBILITY

- **1.** Applicant(s) must be a resident of Manitoba
- 2. This grant aims to assist in the expansion of already-existing works that are already established within the community or are in the later stages of the development process. Applicants must be prepared to share their project, goals and results with others
- **3.** The project must impact local communities, school(s) and/or organization(s) within Manitoba

ONE MORE CANDLE

BRINGS LIGHT TO DARKNESS





FUNDING AWARDED: \$3,000

One More Candle is a registered charity based in Winnipeg that offers the opportunity to adopt the memory of one of the 1,500,000 children murdered in the Shoah (Holocaust) and honour their life by the mitzvah of remembering. The impact of adopting the memory of the child is meaningful and palpable and gives a chance to give light to darkness by saying his or her name out loud or by lighting a candle every year to keep their memory alive.

One More Candle invites everyone: individuals, families, synagogues and groups of any faith, to adopt the memory of a child murdered in the Holocaust, and to honour them by remembering that these children have lived, loved, played and laughed. Through remembrance, education and action we can change the future and secure a better world for our children today.

FUNDING AWARDED: \$2,000

Rights Here, Rights Now was a student-led human rights conference held on April 17, 2018 at Grant Park High School in Winnipeg for over 1,300 students. The conference addressed indigenous reconciliation and a broad range of social justice issues with keynote speakers, interactive activities and performance pieces.

The underlying theme was recognizing the past, living the present and changing the future by initiating a learning and healing process, inspiring Grant Park students to volunteer, take action and make a difference in their community. Discussions included the following themes: Women's Rights, LGBTTQ*, Refugees, Discrimination, Hate Speech and Poverty.
